Scholarship Award Rules

The following criteria will be considered in awarding the scholarships:

- a. Academic record (which may include, but is not limited to grades, participation in law review, moot court, or working as a teaching fellow);
- b. Extracurricular activities (with emphasis on service oriented extracurricular activities directed towards the enhancement of opportunities for minorities);
- c. Letters of recommendation;
- d. Financial need; and
- e. Applicant's essay

- 3. Two letters of recommendation, preferably from a teacher, professor or employer.
